#### Packaging

**Biosilico<sup>®</sup> AZ.PC.0198** is supplied in 15 kg bag.

#### Storage and Handling

- Store in closed containers under dry condition; protect the material from volatile substances and handle sensibly to minimize dust generation.
- This product should be used within 24 months from production date.

#### Safety Data
